Can a federal solar tax credit be combined with other incentives?

You can combine the federal solar tax credit with other incentives like state solar tax credits to maximize your solar savings. However, whether it's a utility rebate, a state tax credit, or a performance-based incentive can impact how the federal solar tax credit is calculated.

How does a solar PV rebate work?

For example, if your solar PV system was installed before December 31, 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows:

Do solar rebates work?

Several states offer rebate programs that cover some or all of the cost of purchasing a home solar system and/or battery storage. These rebates can work in addition with the federal tax credit to increase the savings of going solar. For example: Maryland offers a \$1,000 rebate for solar photovoltaic and solar shingle installations above 1 kW.

What is the federal solar tax credit?

The federal solar tax credit, formally known as the Residential Clean Energy Credit, is an incentive you can earn when installing solar panels or other clean energy equipment on your property. The tax credit equals 30% of installation costs and can reduce what you owe in federal income taxes by thousands of dollars.
