) Lien. The Landlord shall have a lien on any property placed in the storage space and have the right to sell the property at public or private sale as provided under State law. USE. The Tenant may use the storage space to store their personal property.

Can a tenant alter a storage space?

The Tenant is not allowed to make any type of alteration to the storage space without the express written permission of the Landlord. INSPECTION. The Landlord has the right to access and inspect the storage space at any time for repairs, modifications, or emergency purposes. LIABILITY.
